Rules And Regulations - Booth Rental Agreement - 2022

Dates: Saturday October 22nd (Rain Date October 29th)

Set-up: Vendors will be placed in their designated spots Saturday October 22nd from 9:00am – 4:00pm. *These are the only hours vendors will be able to move in to their space unless other arrangements have been made prior to set-up day.*

Removal: All concessions must be removed no later than 4:00pm Saturday immediately following festival.
